SUPERVISOR'S REPORT:

Reported that a donation request was received from the William B. Ogden Library. He stated the request was received too late, as the 2016 Budget has been adopted.

Reported that notice from Homeland Security and Emergency Services was received notifying the Town of funding in the amount of \$15,026.86 from the declared event on July 12, 2013.

Reported that a letter from South Mountain Wind was received informing the Town that the company wishes to withdraw their Wind Energy Facilities Permit application. The company explained that too much time had elapsed to allow the project, leading NWP to reluctantly abandon the project. Supervisor Dolph stated that they have requested the repayment of the escrow funds.
