HUMANE SOCIETY AGREEMENT

Reported that a renewal for Gas and Electric Supply Agreement has been received. Although the current agreement does not expire until April 2020, it was suggested locking into the rates, as they are lower than the current lock in rate.

SUPERVISOR'S REPORT:

RESOLUTION #92 COMMUNTIY RECREATION GRANT

WHEREAS, the Community of Walton has identified a need for the development of a park, boat ramp, and recreation trail project within the Village of Walton; and

WHEREAS, the Village of Walton and the Town of Walton have agreed to work together to create a community waterfront park on properties owned by both municipalities; and

WHEREAS, the Village has contracted with the Delaware County Soil and Water Conservation District to complete a flood plain reclamation project which has created a large open space between the Village Center and the West Branch of the Delaware River; and

WHEREAS, the Village of Walton and Town of Walton have worked together to complete a flood mitigation master plan which resulted in a conceptual development plan for the creation of outdoor recreation parks within the Village; and

WHEREAS, the Village has identified an appropriate funding opportunity and intends to apply for funding; and

WHEREAS, the project will create a more enjoyable, sustainable, and walkable community and result in a safer and healthier community; and

WHEREAS, the project will require grant funding in order to bring the project to fruition; and

WHEREAS, applications are being accepted by way of the Consolidated Funding Application for requests under the Environmental Protection Fund through the New York State Office of Parks, Recreation, and Historic Preservation; and

WHEREAS, as a requirement of these programs, said municipality must obtain the approval/endorsement of the governing body of the municipality in which the project will be located.

NOW THEREFORE BE IT RESOLVED, that the Town Board of the Town of Walton does hereby approve and endorse the submission of applications for a grant under the Environmental Protection Fund for a park, boat ramp, and recreation trail, and associated amenities within the Village of Walton, Delaware County, New York.

RESOLUTION #92 <u>COMMUNTIY RECREATION GRANT</u>

A motion was made by Councilwoman Wood, seconded by Rodriguez-Betancourt to approve a Consolidated Funding Application grant under the Environmental Protection Fund with the Village of Walton for a park, boat ramp, and recreation trail. All in favor, motion carried.

RESOLUTION #93 <u>LETTER OF SUPPORT</u>

A motion was made by Councilman Armstrong, seconded by Rodriguez-Betancourt granting Supervisor Cetta to send a letter of support to NYS Office of Parks, Recreation and Historic Preservation on behalf of the Village of Walton's application for funding under the 2019 Environmental Protection Fund Grant Program. All in favor, motion carried.

Supervisor Cetta reported that he will meet with Dan Watson on July 17th to discuss the solar farm pilot.

Councilwoman Wood suggested that the Town of Walton pursue the Opportunity Zone. The Town and Village have been declared an Opportunity Zone by the State as a result of our poverty level. After a lengthy discussion, Supervisor Cetta suggested Councilwoman Wood meet with realtors and report back to the Board.
