#### RESOLUTION #100 <u>APPROVAL OF MINUTES</u>

A motion was made by Councilman Govern seconded by Rodriguez-Betancourt approving the minutes of September 11, 2023 as presented. All in favor, motion carried.

#### **ASSESSOR REPORT:**

Supervisor Cetta informed the Board that the RFP has been completed and is ready for advertisement.

Councilman Rodriguez-Betancourt questioned why did the assessor not keep the assessment at 100%? Supervisor Cetta explained that there were a number of factors that contributed to our rate dropping from 100% to 77%. He mentioned one being that our assessor only works 20 hours a week and this type of work cannot be done in that time frame.

Councilman Rodriguez-Betancourt and Councilman Armstrong were concerned the cost of a townwide reevaluation will not produce a great enough impact to the assessed valuation or address the situation of maintaining 100% assessing.

Supervisor Cetta stated that NYS suggests budgeting for a townwide revaluation at least every 4 years and confirmed if the Board does not like what the RFP's come in at that they have the right to reject them.

Discussion took place for an additional option of hiring a parttime assistant to the assessor. Supervisor Cetta stated he would have the Assessor compile information and bring back to the Board.

## RESOLUITON #101 <u>ADVERTISE FOR RFP FOR TOWNWIDE RE-EVALUATION</u>

#### RESOLUTION #102 SPECIAL MEETING FOR A BUDGET WORKSHOP

A motion was made by Councilwoman Wood, seconded by Govern to schedule a Special Town Board meeting for October 16, 2023 at 7:00p.m. for the purpose of a budget workshop and any other business that comes before the board. All in favor, motion carried.

#### RESOLUTION #103 PUBLIC HEARING

A motion was made by Councilman Armstrong, seconded by Wood to approve a Public Hearing on November 13, 2023 at 6:00 p.m. for the purpose of those wishing to speak in favor or against the 2024 Preliminary Budget for the Town of Walton. All in favor, motion carried.

I presented to the Board the following resolution for the purpose of implementing a rental fee of \$25.00 per use for Veteran Plaza and More Park to become effective January 1, 2024.

Councilman Rodriguez-Betancourt questioned who would be responsible if someone were to get hurt on the plaza during a rental. Councilwoman Wood and Town Attorney Walas pointed out the waivers and requirements on the application.

#### **USE OF FACILITIES POLICY**

A motion was made by Councilperson Govern, seconded by Wood to adopt the use of facilities policy as amended.

#### Resolution#104

**WHEREAS**, the Town of Walton implemented a Use of Facilities Policy as on June 12, 2007 and required a \$50.00 use deposit from any interested parties or organizations for the use of Veteran's Plaza and More Park; and

**WHEREAS**, the Town of Walton has seen an increase in the use and maintenance of Veteran's Plaza and More Park; and

**WHEREAS**, the Town of Walton wishes to offset the cost of increased maintenance by implementing a rental fee of \$25.00 per use from all interested parties or organizations for Veterans Plaza and More Park; and

#### NOW, THEREFORE, BE IT

**RESOLVED**, that the Town of Walton hereby amends the Use of Facilities Policy and will no longer require a \$50 deposit, but will charge a rental fee of \$25.00 per use from any interested parties or organizations for Veterans Plaza and More Park;

# RESOLUTION No. 105 INTRODUCING LOCAL LAW NO. 1 OF 2023 ANIMALS: IMPOUNDMENT OF DOGS FOR SAFE KEEPING

At a meeting of the Town Board of the Town of Walton, Delaware County, New York, held at 129 North Street, Walton, NY 13856, on the 2nd day of October, 2023, there were:

Supervisor Joseph Cetta Councilman Kevin Armstrong Councilman Leonard Govern Councilwoman Patricia Wood Councilman Luis Rodrigue-Betancourt Councilperson Armstrong offered the following resolution and moved for its adoption:

BE IT RESOLVED that an introductory Local Law entitled

#### "LOCAL LAW NO. 1 OF 2023 IMPOUNDMENT OF DOGS FOR SAFE KEEPING"

is hereby introduced before the Town Board of the Town of Walton, Delaware County, New York pursuant to authority under the New York State Constitution, the provisions of § 10 of the New York State Municipal Home Rule Law, § 10 of the New York State Statute of Local Governments, and the New York State Town Law;

BE IT FURTHER RESOLVED that copies of the aforesaid proposed local law be laid upon the desk of each member of the Board;

BE IT FURTHER RESOLVED that the Board hold a public hearing on said proposed local law at 129 North Street, Walton, NY 13856 at 6:00 pm on November 13, 2023;

BE IT FURTHER RESOLVED that the Clerk publish or cause to be published a public notice in the official newspaper of the Town of Walton of said public hearing at least five (5) days prior thereto;

and BE IT FURTHER RESOLVED that the Town Supervisor or his designee is authorized to take any other action required under law in furtherance of this resolution and passage of the proposed local law.

#### RESOLUTION #107 <u>DEDICATION PLAQUE</u>

A motion was made by Councilwoman Wood, seconded by Rodriguez-Betancourt authorizing the Walton Chamber of Commerce to place a plaque at Veterans Plaza dedicated to George Ostrowski. All in favor, motion carried.

Councilwoman Wood questioned Supervisor Cetta on the status of the Host Community Agreement. Supervisor Cetta state he has not discussed the issue and did not feel he would have support. Councilman Armstrong stated that was a costly attorney fee for nothing. Councilman Govern felt our previous predecessor left us with an issue.

Councilwoman Wood questioned what can we do about the IDA selling the property to someone that plans to build a cannabis grow facility? She stated that the location is not ideal and has concerns of the amount of water that will be used. Supervisor Cetta stated he asked Glenn Nealis Director of Economic/Industrial Development to hold an informational meeting to inform the public. Mr. Nealis has not responded to these requests.

Councilman Rodriguez-Betancourt questioned if the Village gave permission to construct a grow facility and why did the IDA not sell to local buyers? Supervisor Cetta stated this is why I wanted Mr. Nealis to come and address these questions to the public.

Councilwoman Wood suggested sending a letter to all residents informing them of what is coming. Councilman Armstrong stated he did not like the idea of the town telling the village how to run their business. Councilman Govern suggested that Supervisor Cetta send a letter to the mayor asking that the Village inform the residents of what is coming. After discussion, it was agreed that Supervisor Cetta would send a letter to the mayor stating the Towns opposition.
