#### FLOOR TIME:

Robert Koszarek from KLW stood forward and spoke about the finalization of the reassessment for the Town and Village. Koszarek explained what the purpose of the reassessment was, and what happens after everything is finalized and what comes next.

Supervisor Cetta asked if the reassessment was meeting the timeline goal and Koszarek reported that everything was on schedule and will be finished when anticipated.

Glenn Nealis stood forward next to speak about the Sheffield Estates and what process they are going through to get to where they want to be. He said they met with Village Planning Board in December and he is waiting for the site plan to get preapproved, so they can move forward and get the first lot marketed and so they can use the funds to move on with the second lot.

Councilman Govern asked if they have a timeline of when they want to be finished and Nealis explained that hopefully in April they will have their permits to move forward and contract out for the site work and as soon as that is finished, they can list it and go from there.

Supervisor Cetta asked if there was any entity Nealis explained that he is taking inquiries from any business but there is no one specific and will make a decision based on who meets all the requirements, which who will do the most in job creation because that is the goal.

Financial Reports have been provided.

Tax collection is going well, I have learned a lot and I find that the Town Clerk position wears many different hats with tax collection, vital records, clerk duties and being a general information source for the residents. We have had one court awarded small claims that will result in a tax refund of \$ 284.38 we are waiting to hear from the Delaware County Treasurer to see if they will be issuing the refund since I have already made the Supervisor whole.

Reported that I am 72% collected and that although only 19 people took advantage of the partial tax payments, over 168 have utilized the on-line payment services.

I have applied for a NYS Town Clerk Scholarship with hopes to offset the conference expenses. I will not find out if I received the scholarship until I go to conference and then it would be a reimbursement.

The Annual Financial Report for 2024 has been filed with the State and is available for review in my office.

#### RESOLUTION #42 <u>2024 BUDGET AMENDMENTS</u>

A motion was made by Councilman Govern, seconded by Rodriguez-Betancourt approving the 2024 budget amendments as submitted to close out the 2024 Fiscal year. All in favor, motion carried.

#### SUPERVISOR'S REPORT:

Supervisor Cetta started by stating he received a thank you card from the VFW; every year we budget \$500 because they put together the parade and they buy the flags for the Veterans Graves in the Cemetery. The Legion is putting together a committee to revise the format of the parade to see if we need to adjust anything with the parade.

#### **COMMITTEE REPORT:**

Councilwoman Wood spoke about the Water Street sign and which sign company we can use for making the sign inserts and install, she stated that the sign company we have started with a ball park of \$600 to install the sign. Councilman Rodriguez-Betancourt suggested that we can replace and install the sign with the Town's equipment so it wouldn't be as expensive. Wood suggested we use the sign company just so that we don't have the liability if something were to happen. Further discussion will take place upon the completion of the lease agreement.

Supervisor Cetta stated that he attended the meeting with a number of entities in reference to the emergency plan and there is more work they have to do to put stuff together. Cetta was very pleased with the turnout and the discussions that were taken place, but there will be more to follow on that after the next meeting, which is February 24<sup>th</sup>.

Councilman Govern spoke on the current Emergency plan stating it needs to be updated if that is what people are going off of.

Councilman Govern spoke about a Grant from the Delaware County Historical Association to work on cemeteries that contain Revolutionary War Veterans that have been abandoned. The Grant money could be used to help clean up grave sites as well as repairs to monuments.
